TO THE HONORABLE THE JUDGES OF SAID COURT:

In compliance with the requirements of an Act of the General Assembly of the Commonwealth of Pennsylvania, entitled "An Act to provide for the incorporation and regulation of certain corporations," approved the 29th day of April, 1874, and the several supplements thereto, the undersigned, all of whom are citizens of the United States and of the Commonwealth of Pennsylvania, having associated themselves together for the purposes hereinafter specified, and desiring that they may be incorporated and that a charter may be issued to them and their associates and successors according to law, do hereby certify:

(1). The name of the intended corporation is:

TRAFFORD SPORTSMEN'S CLUB.

(2) The said corporation is formed for the purpose of engaging in hunting, fishing and shooting mark, as well as taking part in all other forms of outdoor sport; it is further the purpose of said corporation to interest itself in the preservation of the wild life, streams and forests of Pennsylvania, as well as in the propagation of said wild life.

(3) The place where the business of said corporation is to be transacted is in the Township of Penn, Westmoreland County, Pennsylvania.

(4) The said corporation is to exist perpetually.

(5) Many of the members own the real estate on which they live and are in all respects good and worthy citizens of the United States and of this Commonwealth. English shall be the official language of said corporation.

(6) The yearly income of said corporation from all sources other than real estate shall not exceed the sum of twenty thousand (\$20,000.00) dollars.

(7) The said corporation has no capital stock. Fees for membership and dues of the members shall be assessed as the corporation by its By-Laws shall determine, which fees and dues, as well as money derived from all other sources, shall be applied to promoting the purposes for which the corporation is formed.

(12) The corporation shall have power from time to time to alter, amend or revise its Constitution and By-Laws, provided that no alterations or amendments shall be inconsistent with the Constitution or laws of the United States or the Commonwealth of Pennsylvania or the provisions of its charter.
